52nd ANNUAL BLUEWATER INVITATIONAL TOURNAMENT RULES Fish Days: May 13th – May 18th

Registration/Check-in: All registered boats must be checked-in with the Tournament Committee and entry fee paid by 7:00 pm, May 10th to qualify for prizes and trophies. **See additional details in Section 6.** The Tournament Committee reserves the right to deny entry to anyone. All registered boats and anglers must be in compliance with Federal and State Regulations regarding recreational and/or charter fishing.

Captain's Meeting: At least one representative from each boat must be present at the Captain's Meeting and is responsible for all information provided at the meeting.

Tournament Rules:

- 1. Boats are required to leave from any Georgia inlet or Calibogue Sound, SC. Boats may not leave the dock before 12:01AM the day of the declared fish day. No lines in the water before 7:00 am, including teasers and fishing for live bait. Lines out of the water each day at 3:00 pm. A boat may finish fighting a fish that was hooked prior to 3:00 pm.

 Scanning sonars will NOT be allowed. Boats must declare a fishing day to the Tournament Committee by telephone, cell phone, email or in person by 9:00 pm of the prior day. If necessary, a boat may withdraw their fishing day declaration up to and including 6:00 am of that day by making contact with the Tournament Committee or a Committee Boat. A withdrawal for that day of fishing must be received and confirmed by the Tournament Committee or Committee Boat, not merely attempted. In order to accommodate mechanical or other unforeseen problems, boats may be substituted until 6:00am of their first declared fish day.
- 2. This is a Captain's Choice Tournament where Boats may fish two-out-of-six eligible fishing days. A boat's single best fish day only will count in the tournament. Eligible fishing days are: **Monday May 13th through Saturday May 18th**. In the event no boats choose to fish any of these six days of fishing, then Sunday May 19th shall be a fishing day. One boat fishing one day constitutes a tournament.
- 3. A Small Craft Advisory **will not** cancel any fish day of the Tournament. The boat's Captain and/or Owner is responsible for the decision to fish on any day and assumes sole responsibility for the safety of the vessel and crew.
- 4. Official Tournament Time is Eastern Standard Time.
- 5. The official VHF channel of the tournament is 68.
- 6. **The entry fee will be \$1,500 per boat.** Registration will be open until 7:00 pm, May 10th. Payment can be made online at ssfc.org or by check. Please contact the Tournament Committee if paying via check.
- 7. All fish must be caught in accordance with all state and federal laws, and under IGFA Rules with the exception of passing a rod. After a fish strikes, the rod may be passed to one angler one time as soon as possible. All anglers may have the rod passed one time to them. After the rod has been passed, only the angler is allowed to touch the rod, reel, line. Once the leader is brought within the grasp of the mate or is wound to the rod tip, then the angler may have assistance to catch and release or boat the fish. Violations of state or federal law will lead to the disqualification of all fish caught on that fishing day, and the boat will forfeit one of the two days of eligibility.
- 8. This is a rod and reel, hook and line tournament. Boats may fish a maximum of seven (7) rods at one time. Double line and leader may not exceed 40ft; neither of which may exceed 30ft. The following practices are **illegal** in this tournament: a) use of hand line or rope attached to the line or leader, b) shooting, harpooning, or lancing.
- 9. Effective January 1, 2008, The National Marine Fisheries Service regulations require anglers fishing from HMS permitted vessels and participating in Atlantic Billfish tournaments to use only non-offset circle hooks when deploying natural baits or natural bait/artificial lure combinations. The regulations allow the use of J-hooks with artificial lures in tournaments. All tournament entries will adhere to the NOAA and National Fisheries Service definitions of a "non-offset circle hook".

- 10. Boats earn two (2) points per pound for Blue Marlin. The minimum size for a landed Blue Marlin is 400 lbs. or 105 inches, measured in a curved line along the body from the fork of the tail to the tip of the lower jaw. Once boated, a boat's fishing day shall be concluded, and they must immediately head towards the dock and notify the Tournament Committee or Committee Boat. A penalty of 600 points will be assessed against a boat for each blue marlin brought to the dock not meeting the minimum size requirements. Note: 105 inches exceeds the federally mandated minimum size limit. The State of Georgia men's Blue Marlin record is currently 491 lbs 8 oz. Given the recent regulation change now allowing for the taking of a Blue Marlin again, boats are encouraged to only take Blue Marlin exceeding the current men's state record. The marlin must weigh 493 pounds and 15 ounces to qualify for the new state record.
- 11. Billfish boated for any reason will not qualify for release points. A billfish may not be brought into the boat unless it is to be brought to the dock for weighing. Any billfish gaffed, harpooned or otherwise injured in an attempt to boat the fish will not qualify for catch and release points. Additionally, if the gaff crosses the vertical plane of the boat in an attempt to land a blue marlin yet it is unsuccessful, the boat will not qualify for catch and release points. A penalty of 600 points will be assessed against a boat for each billfish, regardless of species, that is determined to have been boated and subsequently released.
- 12. White marlin, Spearfish and Sailfish are catch and release only. Tagging is optional and not required for points. Only Blue Marlin, White Marlin, Spearfish and Sailfish are eligible for catch & release points. Scoring for billfish caught and released in good condition is as follows:

Blue Marlin 600 Points White Marlin/Spearfish 300 Points Sailfish 200 Points

- 13. A billfish is considered caught and release points will be awarded when **all** the following has occurred: 1) the leader is grasped by the mate or the leader is wound to the rod tip (a leader may be no longer than 30 feet); 2) **the billfish is positively identified to species through digital photography/videography (if species cannot be determined yet is identified as a billfish, 200 points will be awarded);** and 3) the fish is released in a healthy condition and the fish is no longer attached to the boat/line. Boats are encouraged to remove the hook or cut the line as close as possible to the hook.
- 14. All released billfish must be **clearly photographed/video graphed** with a digital device provided by each boat. Each boat is required to keep their billfish photography/video on their device until after the Awards Ceremony has taken place. All boats are subject to random photography/videography checks throughout the tournament. Leading boats will be required to submit their camera and/or chips to the Tournament Rules committee following fishing on May 18th, 2024. Fish verification will be at the sole discretion of the Tournament Rules committee. Preferable photo/video would include a visible dorsal fin at time of release. The image must include a time and date stamp that corresponds to the time of release recorded by the tournament designated committee boats. Photos must be provided in jpeg format on a removable storage device, and will be used to confirm species identification, release information, and will be used to resolve potential conflicts or formal protests.
- 15. All billfish hook-ups, catch & releases, and landings must be reported as they occur to a committee boat or another boat that can relay the message to a committee boat prior to or by 3:00 p.m. each day. (Note: the goal is to have the traditional one or two boats designated as Committee Boats each fishing day. In addition, each boat in the tournament is asked to record any and all hook-ups, get-away, releases or landings that it may hear. Due to the wide range of fishing territory allowed, this will help ensure that all calls are recorded)
- 16. Blue Marlin having mutilation hindering its ability to fight will be disqualified. All fish must be in edible condition and properly processed. Any fish wantonly wasted will be disqualified. All landed Blue Marlin are to be iced or refrigerated until such time as they are released by tournament officials to the boat, after which the edible tissue should be processed and the carcass disposed of as soon as possible. (PLEASE NOTE: IT IS VERY IMPORTANT that you come to the Tournament prepared with sufficient coolers and tools for the dressing of your Blue Marlin should you bring one in to the scales. See to it that you quickly set about the task of this effort after all pictures are taken.)
- 17. Meat fish shall include Dolphin, Wahoo, and Tuna (only Yellowfin, Blackfin, Bluefin, or Bigeye). Each boat is allowed to weigh two fish per species and will earn **1 point per pound**.
- 18. Monetary prizes will be awarded to the 1st, 2nd, and 3rd place boats, 1st place outboard division, largest mahi, along with a trophy for each category. The Mary Buck Trophy will be awarded to the top Lady Angler. The top Youth Angler (14 & under) will be awarded a \$500 cash prize along with a trophy. Note: Lady Anglers and Youth Anglers will elect which of their 2 fish days will count as their tournament day. This can be independent of the boat's tournament day.

- 19. Weigh Scales open at the Savannah Yacht Club Bilge Club at 5:00 pm each fish day. All boats intending to weigh in shall be past the southern end of the Savannah Yacht Club face dock no later than 7:00 pm and shall weigh in as fast as safely possible, but under no circumstances later than 8:00 pm.
- 20. In the event that a Marlin is hooked during fishing hours and due to an extended fight, the boat is not back prior to 7:00 pm, the boat shall be disallowed meat fish points, but shall have until the end of the next day's weigh-in or, if fishing the final fish day, 9 AM on Sunday 5/19 to present proof of release to the weigh-in committee or have the fish weighed by the weigh-in committee. An attempt to contact the Committee Boat before lines out of water time must be made to notify a Tournament Committee member of the extended Marlin fight. In the event a boat has boated a Blue Marlin, the boat will have until 9AM on the next day to pass the southern end of the Yacht Club face dock to be eligible to weigh the fish.
- 21. Ties in points are broken by the earlier weigh in time. A legal Blue Marlin at the dock prior to scales opening at 5:00 pm will automatically open the scales early for that boat only. Weigh in time for that boat, including any additional meat fish or billfish release points, shall be at the time in which they weigh the Blue Marlin.
- 22. All fish must be weighed in by boat and a boat docking at any facility other than the Savannah Yacht Club after lines in water and prior to weigh-in will be disqualified.
- 23. Any protest must be submitted in writing with a \$250 protest fee to any member of the Rules Committee by no later than 30 minutes after the conclusion of weigh-in on the final fish day of the tournament. This fee will be refunded if the protest is proved valid. A polygraph test may be required if the Committee deems necessary. The ruling of this Committee is final.
- 24. This Tournament is an Offshore World Championship Qualifying Event. The Tournament winner will be qualified to fish in the 2024 Championship in Quepos, Costa Rica. For more information, please visit www.offshoreworldchampionship.com.
- 25. Your participation in this tournament signifies agreement to abide by all rules and you release the Savannah Sport Fishing Club, the Savannah Yacht Club, and officers, directors, employees, and sponsors of the same from any injury, loss or damage which may result to you, your vessel or any crew members from participation in this event.

All Participants enter at their own risk. The Savannah Sport Fishing Club, and Sponsors hereby disclaim any and all legal liabilities for property damage, bodily injury and all losses or damages of any kind to property, participants and/or any persons involved in this tournament. Participants in this tournament are advised to obtain insurance covering vessels and crew.

I have read and fully understand all rules of the 52nd Annual SSFC Bluewater Invitational. As Captain/Vessel Master, I am responsible for my crew and boat at all times, and hereby release The Savannah Sport Fishing Club, and Sponsors, their Principals, Agents, Officers and its affiliates from all liability. In consideration of the Tournament accepting this registration, the registrant hereby authorizes the Tournament to use the registrant's name and/or likeness, as well as that of all crew members and vessel, free of consideration, for promotion and advertising purposes in any media form and reproduction, including but not limited to radio, television, newspaper, brochure and video. As Captain/Vessel Master, I further understand it is my sole responsibility to decide to fish and participate in this Tournament.

AMENDMENT TO 52nd ANNUAL BLUEWATER INVITATIONAL TOURNAMENT RULES

The Savannah Sport Fishing Club is offering \$100,000 ("Prize") for an "All-Tackle Georgia State Record Blue Marlin" catch. This is a separate division of the Tournament, and all Tournament rules shall apply except as stated in this Amendment.

The "All-Tackle Georgia State Record Blue Marlin" catch must meet the following conditions:

- The fish must be caught in those waters of the Atlantic Ocean off the Georgia coast eligible for All-Tackle Georgia State Record consideration. The southern and northern lines are as follows, any salt water south of a straight-line due east of the Georgia/South Carolina border, using the point 80°53'25.017" W / 32°02'07.991" N (this is based on O.C.G.A. 50-2-2), and any salt water north of a straight-line due east of the Georgia/Florida border, using the point 81°24'15.9" W / 30°42'45.6" N (based on O.C.G.A. 50-2-5).
- The fish must be caught in the manner prescribed by the IFGA international angling rules.
- The fish must ultimately be certified as the official All-Tackle Georgia State Record for Blue Marlin, and verification of said certification must be readily available to the public from the Georgia state record keeping authority. **The marlin must weigh 493 pounds and 15 ounces to qualify for the new state record.** The qualifications for a state record catch are attached as Exhibit A.
- Any angler who catches said fish must submit to and pass a polygraph examination administered by a licensed polygraphist.
- In the highly unlikely event that there is a tie, the jackpot will be spilt evenly. The largest qualifying marlin caught over the entire length of the six-day tournament will be the winner of the cash prize.

The following Tournament Rules are inconsistent with the Georgia State record qualifying conditions and are provided below for clarification:

Section 1. Boats will be restricted to leaving from and returning to State Waters of Georgia, as referenced, and further described in Exhibit A.

Section 7. Passing of the rod will not be permitted for Blue Marlin catches, as referenced, and further described in Exhibit A.

It is the ultimate responsibility of the team, boat, angler, participant, or same, to ensure that the catch meets the qualifying conditions of the Georgia state record keeping authority.

The Savannah Sport Fishing Club has entered into a separate agreement with a third party to cover the liability of a Prize payout in the event that there is a qualifying All-Tackle Georgia State Record Blue Marlin. The Savannah Sport Fishing Club shall only be liable for payment of the Prize to the participant upon receiving the Prize funds pursuant to the terms of said separate agreement with the third party. In the event a claim for payment of prize from the third party is denied, the Savannah Sport Fishing Club may choose whether to pursue payment of the Prize from the third party at its sole discretion.

Your participation in this division of the Tournament signifies agreement to abide by all rules in this Amendment and you release the Savannah Sport Fishing Club, the Savannah Yacht Club, and officers, directors, employees, and sponsors of the same from all liability.

Exhibit A

GEORGIA SALTWATER GAMEFISH RECORDS ANGLING RULES

Angling rules associated with Georgia's Saltwater Gamefish Records Program are patterned largely after saltwater rules established by the International Game Fish Association. Subtle and obvious modifications, such as the lack of line classes in Georgia regulations, do exist. Each angler should carefully review each set of rules to discern these differences.

Only fish landed in accordance with program rules outlined below and within the intent of these rules will be eligible for status as a Georgia Saltwater Gamefish Record. Like IGFA, the Georgia program is designed to recognize not only the fighting abilities of fishermen and their quarry, but also to promote ethical, sporting angling practices and a greater appreciation of coastal resources.

In light of these considerations, each fisherman must determine whether his achievement reflects the intent and the spirit of these standards. Rules alone cannot ensure that angling experiences equal the catch, or vice versa.

A. SAFETY

Anglers must consider several factors in the pursuit of a Georgia Saltwater Gamefish Record. Primary among these is safety for the angler, crew, and/or vessel. Fishermen should carefully weigh safety demands against the inherent risks associated with certain gamefish, such as sharks, billfish, and other large species. It is ultimately the decision of the angler (and vessel captain, if applicable) to decide whether the catch can be safely accomplished under the existing circumstances and with the knowledge and equipment available.

B. LINE

- 1. Monofilament, multifilament, and lead core multifilament lines may be used.
- 2. Wire lines are prohibited.

C. DOUBLE LINE AND LINE BACKING

The use of a double line is not required. If one is used, it must meet the following specifications:

- 1. A double line must consist of the actual line used to catch the fish.
- 2. The double line shall be limited to 30 feet (9.14m). Double lines are measured from the start of the knot, braid, roll, or splice making the double, to the most distant end of the knot, splice, snap, swivel, or other device used for securing the trace, leader, lure, or hook to the double line.
- 3. The combined length of the double line and the leader shall not exceed 40 feet (12.19m).
- 4. Backing attached to the fishing line is permissible but must be of a type of line approved for use in these angling rules.
- 5. Backing not attached to the fishing line is permissible with no restrictions as to size or material.

D. LEADER

The use of leader is not required. If one is used, it must meet the following specifications:

- 1. The leader shall be limited to 30 feet (9.14m). There are no minimum lengths. The length of the leader is the overall length including any lure, hook arrangement or other device.
- 2. The leader may not be lengthened beyond the stated limitations to compensate for a double line shorter than the maximum length allowed.
- 3. The leader must be connected to the line with a knot, splice, snap, swivel, or other device.
- 4. There are no regulations regarding the material or strength of the leader.

E. RODS

- 1. Rods must comply with sporting ethics and customs. Considerable latitude is allowed in the choice of a rod, but rods giving the angler an unfair advantage will be disqualified. This rule is intended to eliminate the use of unconventional rods.
- 2. Cane or bamboo poles are permitted when used in accordance with normal and ethical angling practices outlined and implied in program regulations. Line, rod, terminal gear, and other equipment used must comply with these rules. Fish snagged or snatched with no opportunity to fight will not be eligible for record status. Applications for catches with cane poles must be accompanied by a full description of the equipment and capture.

F. REEL

- 1. Reels must comply with sporting ethics and customs.
- 2. Power driven reels of any kind are prohibited. This includes motor, hydraulic, or electrically driven reels, and any device which gives the angler an unfair advantage.
- 3. Ratchet handle reels are prohibited.
- 4. Reels designed to be cranked with both hands at the same time are prohibited.
- 5. Specialized reels designed for use by disabled or handicapped fishermen may be allowed. Anglers using these reels, however, must submit with the record application additional background explaining the necessity of the reel, as well as a detailed description of the unit and its operation.

G. HOOKS FOR FISHING WITH NATURAL BAIT

- 1. For fishing with live or dead natural baits, a maximum of two hooks (either single, double, or treble, or a combination of any two) may be used. The hooks must be firmly imbedded in or securely attached to the bait. The eyes of the hooks must be no more than 18 inches (45cm) apart. The only exception is that the point of one hook may be passed through the eye of the other hook or joined by a swivel.
- 2. The use of a dangling or swinging hook is prohibited.
- 3. A two-hook rig for bottom fishing is acceptable if it consists of two single hooks on separate leaders or drops. Both hooks must be imbedded in the respective baits and separated sufficiently to that a fish caught on one hook cannot be foul-hooked by the other.

H. HOOKS AND LURES

- 1. When using an artificial lure with a skirt of trailing material, no more than two single hooks may be attached to the line, leader, or trace. The hooks need not be attached separately. The eyes of the hooks must be no less than an overall hook's length (the overall length of the largest hook used) apart and no further than 12 inches (30cm) apart. The only exception is that the point of one hook may be passed through the eye of the other hook or joined by a swivel. The trailing hook may not extend more than a hook's length beyond the skirt of the lure.
- 2. Gang hooks are permitted when attached to plugs and other artificial lures that are specifically designed for this use. Gang hooks shall be limited to a maximum of three hooks (either single, double, or treble, or a combination of any three). These hooks must be permanently and directly attached to the lure and must be free swinging.

I. OTHER EQUIPMENT

- 1. Fighting chairs may not have any mechanically propelled devices which aid the angler in fighting a fish.
- 2. Gimbals must be free swinging, which includes gimbals that swing in a vertical plane only. Any gimbal that allows the angler to reduce strain or to rest while fighting the fish is prohibited.

- 3. Floats are prohibited except for any small flotation device attached to the line or leader for the sole purpose of regulating depth of the bait. The flotation device must not in any hamper the fighting ability of the fish.
- 4. Entangling devices, either with or without a hook, are prohibited and may not be used for any purpose, including baiting, hooking, fighting, or landing the fish.
- 5. Outriggers, downriggers, and kites are permitted to be used provided that the actual fishing line is attached to the snap or other release device, either directly or with some other material. The leader or double line may not be connected to the release mechanism either directly or with the use of a connecting device.
- 6. A safety line may be attached to the rod provided that it does not in any way assist the angler in fighting the fish.
- 7. Standard, single-hooked fixed and flying gaffs, landing nets, and tail ropes may be used to retrieve a fish when the leader has reached the rod tip. If fishing from a pier or similar structure, gaffs, landing nets, and tail ropes may be used to retrieve a fish when the top of the leader has cleared the surface of the water. Gaffs, nets, or tail ropes may not be used in any to snag, entangle, or otherwise hinder a fighting fish. Harpoon and lance attachments are prohibited.
- 8. Specialized equipment designed to assist disabled or handicapped fishermen may be permitted. Anglers using this equipment must submit with the record application background explaining the necessity of the equipment, as well as a detailed description of the gear and its operation.

J. ANGLING REGULATIONS

- 1. From the time that a fish strikes or takes a bait or lure, the angler must hook, fight, and bring the fish to gaff without the aid of any other person, except as provided in these regulations.
- 2. If a rod holder is used and fish strikes or takes the bait or lure, the angler must remove the rod from the holder as quickly as possible. The intent of this rule is that the angler shall strike and hook the fish with rod in hand.
- 3. In the event of a multiple strike on separate lines being fished by a single angler, only the first fish fought by the angler will be considered for a record.
- 4. A harness may be attached to the reel or rod, but not to the fighting chair. The harness may be replaced or adjusted by a person other than the angler.
- 5. Use of a rod belt or waist gimbal is permitted.
- 6. When angling from a boat, once the leader is brought within the grasp of the mate, or the end of the leader is wound to the rod tip, more than one person is permitted to hold the leader.
- 7. One or more gaffers may be used in addition to persons holding the leader. The gaff handle must be in hand when the fish is gaffed.
- 8. The angling rules and equipment regulations shall apply until the fish weighed.

K. THE FOLLOWING ACTS WILL DISQUALIFY A CATCH

- 1. Failure to comply with equipment or angling regulations.
- 2. The act of persons other than the angler in touching any part of the rod, reel or line (including the double line) either bodily or with any device during the playing of the fish, or in giving any aid other than that allowed in the rules and regulations. If an obstacle to the passage of the line through the rod guides has to be removed from the line, then the obstacle (whether chum, float line, rubber band, or other material) shall be held and cut free. Under no circumstances should the line be held or touched by anyone other than the angler during this process.
- 3. Resting the rod in a rod holder, on the gunwale of the boat, or on any other object while playing the fish.
- 4. Handlining or using a handline or rope attached in any manner to the angler's line or leader for the purpose of holding or lifting the fish.

- 5. Shooting, harpooning, spearing, or lancing the fish being played (including sharks) during any stage of the catch.
- 6. Chumming with or using as bait the flesh, blood, skin, or any part of mammals other than hair or pork rind used in lures designed for trolling or casting.
- 7. Beaching or driving into shallow water any fish hooked from a boat to deprive the fish of its normal ability to swim.
- 8. Changing the rod or reel while a fish is being played.
- 9. Splicing, removing, or adding to the line while the fish is being played.
- 10. Intentionally foul-hooking a fish.
- 11. Catching a fish in a manner such that the double line never leaves the rod tip.
- 12. Attaching the angler's line or leader to part of a boat or other restraining object for the purpose of holding or lifting the fish.

L. THE FOLLOWING SITUATIONS WILL DISQUALIFY A CATCH

- 1. When a rod breaks in a manner that severely impairs its angling characteristics.
- 2. Mutilations to the fish caused by sharks, other fish, mammals or propellers that remove or penetrate the flesh (Injuries caused by leader or line, old healed scars or regeneration deformities are not considered to be disqualifying injuries). Any mutilation on the fish must be fully explained in a separate report accompanying the record application.
- 3. When a fish is hooked on more than one line.
- 4. Illegal catches (ie., under-sized, out-of-season, etc.) at variance with state or federal laws.
- 5. Fish landed offshore shall not be eligible for record status if the vessel boating the catch enters any other state's or nation's port prior to returning to Georgia moorings.

M. ELIGIBLE WATERS

Any catches entered for consideration as a Georgia Saltwater Gamefish Record must have been hooked in Georgia's saltwaters (as defined by O.C.G.A. Section 27-4-1) or in waters east of the Georgia coast. No applications will be accepted for entries caught in private waters or controlled private bodies of water.

O. SALTWATER GAMEFISH RECORDS REVIEW COMMITTEE

- 1. All record applications will be reviewed and evaluated by the Georgia Saltwater Gamefish Records Review Committee. All Committee decisions will be based on both the letter and intent of the regulations. The Committee's decisions will be final. Further, the Committee and DNR reserve the sole right to either grant or reject any application.
- 2. Catches made with new or specialized equipment and/or methods, protested applications, disputed records, and similar program issues shall be referred to the Saltwater Gamefish Records Review Committee. In the case of specialized equipment and methods, the Committee shall decide if either is justified or allow the angler an unfair advantage.

 Committee decisions on this and all other matters shall be final.
- 3. The Georgia Saltwater Gamefish Records Program shall be re-evaluated biennially and updated by the Saltwater Gamefish Records Review Committee.
- 4. In some instances, the Saltwater Gamefish Records Review Committee may recheck information supplied on a claim. Such action is not to be regarded as doubt of the formal affidavit, but rather as evidence of the extreme care with which the program will investigate and maintain its records.

P. WEIGHTS NEEDED TO DEFEAT OR TIE EXISTING RECORDS

- 1. Minimum weights have been established for certain species and are noted in the rules. Entries in these categories should either meet or exceed the minimum weights established in order to be considered for record status.
- 2. To replace a record for a fish weighing less than 20 pounds (9.07 kg), the replacement must weigh at least 4 ounces (113.39 gm) more than the existing record.
- 3. To replace a record for a fish weighing 20 pounds (9.07 kg) up to 100 pounds (45.35 kg), the replacement must weigh at least 8 ounces (226.7 gm) more than the existing record.
- 4. To replace a record for a fish weighing 100 pounds (45.35 kg) or more, the replacement must weigh at least one half of 1 percent (.005%) more than the existing record weight. Example: At 200 pounds (90.71 kg) the additional weight required would be 1 pound (.45 kg).
- 5. Any catch which matches the weight of an existing record or exceeds the weight by less than the amount required to defeat the record will be considered a tie. In case of a tie claim involving more than two

- catches, weight must be compared with the original record (first fish to be caught). Nothing weighing less than the original record will be considered.
- 6. Estimated weights will not be accepted (See Weighing Requirements).

Q. TIME LIMIT ON CLAIMS

- 1. Claims for record fish should be received within 30 days of the date of catch, although older applications properly completed will be considered for record status. It should be noted, however, that older claims are typically more difficult to verify, especially where additional information is required. In instances where an application cannot be adequately investigated, it is probable that the entry will not be accepted for record consideration.
- 2. If an incomplete record claim is submitted, it must be accompanied by an explanation of any certain portions which are incomplete. An incomplete claim will be considered for a record if the following conditions are met:
 - (a) The incomplete claim with explanations of why portions are incomplete must be received by DNR.
 - (b) Missing data must be due to circumstances beyond the control of the angler making the record claim.
 - (c) All missing data must be supplied within a period of time considered to be reasonable in view of the particular circumstances.
- 3. Final decisions on incomplete claims will be made by the Saltwater Gamefish Records Committee.

R. WEIGHING REQUIREMENTS FOR RECORD FISH

- 1. The weight of the sling, platform, or rope (if one is used to secure the fish on the scales) must be determined and deducted from the total weight.
- 2. The signature and address of the weighmaster (the owner or regular operator of the scale) is required on all entries. If available, witnesses to the weight and their addresses should also be included on the application. Disinterested witnesses to the weight should be used whenever possible. All record fish must be weighed on scales that have been checked and certified for accuracy by government agencies or other qualified and accredited organizations. All scales must be regularly checked for accuracy and certified in accordance with applicable government regulations at least once every twelve months.
- 3. If at the time of weighing the fish, the scale has not been properly certified within twelve months, it should be checked and certified for accuracy as quickly as possible, and a report of the findings included with the record application.
- 4. DNR reserves the right to have any scale recertified for accuracy if there are any indications that the scale might not have weighed correctly.
- 5. No estimated weights will be accepted. Fish weighed at sea or in other bodies of water will not be accepted.

S. SPECIES IDENTIFICATION

- 1. It is the angler's responsibility to provide the data and photographs necessary for proper species identification by the Saltwater Gamefish Records Review Committee. The quantity and quality of information submitted must be determined by the angler.
- 2. If it is possible that there may be a question regarding species identification, several clear photographs showing the full length of the fish and its distinctive anatomical features should accompany the application.
- 3. Further support in species identification (especially groupers, mackerels, sharks, and tunas) may be provided through verification by a qualified ichthyologist or biologist, whose examination should be attached to the application. If a catch cannot be examined immediately, the fish should be frozen or otherwise retained until identified.

4. The identification of certain species of sharks and tunas are typically difficult. Sharks should be photographed lying down to show the relative positions and characteristics of all fins and gill openings. Representative teeth from the upper and lower jaws are also useful. For younger and smaller tunas, excluding little tunny, removal and preservation of internal organs for later examination by a fishery biologist is recommended.

T. PREPARATION OF RECORD CLAIMS

- 1. To apply for a state record, the angler must submit a Georgia Saltwater Gamefish record application form and an acceptable photograph of the angler and the fish. Any additional photographs taken or needed for species identification should also be submitted with the application.
- 2. The official Georgia Saltwater Gamefish record application form must be used for record claims. This form may be reproduced as long as all items are included. The angler should fill in the application personally. It is also recommended that the angler personally mail the application and photographs. Extreme care should be exercised in measuring the fish as the measurements are often important for weight verification and scientific studies. See the measurement diagram on the record application to be sure you have measured correctly.
- 3. The angler is responsible for seeing that the necessary signature and correct addresses of the boat captain, weighmaster, and witnesses are on the application.
- 4. On record claims, witnesses to the catch are highly desirable if possible.
- 5. Any deliberate falsification of an application will disqualify the applicant for any future state record and any existing records will be nullified.

U. PHOTOGRAPHS

- 1. A photograph of the angler with the fish is required. If possible, the rod and reel used to make the catch and the scale used to weight the fish should be included.
- 2. Digital photographs are preferred (high resolution) but are not a prerequisite for proper submission of a record application.
- 3. All photographs submitted with record applications become the property of DNR and may be used in program news releases, publications, and exhibits.

V. OUTSTANDING CATCH

Catches that do not qualify for gamefish record status are eligible for recognition as an Outstanding Catch. Examples of applications that may be considered by the Saltwater Gamefish Records Review Committee include landings of non-record program species, near-record entries, catches made under exceptional conditions (angler age, etc.) and circumstances, fights demonstrating outstanding angling abilities and sporting ethics, and more. Upon approval, catches such as these will receive appropriate certification and will be filed for later consideration for inclusion in the records category. If an Outstanding Catch is approved for entry onto the list of species eligible for saltwater record status, then it and all other outstanding catches of that particular fish will be considered for salwater gamefish record status.
